What Does This Warranty Cover?

This warranty covers defects in materials or workmanship in all components of your **PPB** 4000 Perfect Pool Bottom package. The components of this package are the **PPB** 4000 bottom material and the Gladon Pool Cove.

How Long Does This Warranty Last?

This warranty lasts for ten (10) years from the date of purchase. Coverage terminates, if you sell or otherwise transfer ownership of your *Perfect Pool Bottom* package, or transfer ownership of the pool in which this product has been installed.

What Will Gladon Company Do To Correct The Problem?

Gladon Company, Inc. will replace any component that we determine is defective. If the product is found to be defective in the first ten (10) years of ownership, the component(s) will be replaced at no charge, except for the cost of shipping the replacement component(s). The owner of the *Perfect Pool Bottom* package will be responsible for paying the shipping charges, prior to shipment, with a check or major credit card.

How Do You Get Warranty Support?

In order to be eligible for this warranty you **MUST** return the warranty registration card within 30 days of purchasing your *Perfect Pool Bottom* package. If a defect is discovered during the warranty period, send a letter to Gladon Company, Inc. describing the nature of the defect. Please include your warranty registration card number in the letter and include a photocopy of your dated sales receipt. Let us know how we can contact you to resolve your problem.

What Is Not Covered Under This Warranty?

This warranty relates only to manufacturing defects and does not include damage or failure from other causes. There is no coverage for the *PPB 4000* bottom material, if it has been installed without using *Gladon Pool Cove*.

Gladon Company, Inc. will not be responsible for any replacement labor charges, pool water, chemicals, liner or any other related expenses that may be incurred. This warranty is void if the product is exposed to excessive heat, cold, or to abuse. This warranty applies only to the original retail purchaser and applies only when the product is used for residential swimming pool bottoms.

Gladon Company, Inc. shall not be liable for any consequential or incidental damages, including but not limited to any damages for loss of use of pool or injury to person or property, and any claims therefore are hereby specifically disclaimed and excluded. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.
